- **Temporarily:** for a provisional period.
- **Permanently:** for all time.
- **Importer:** any person (or business) who imports into Jamaica any commodity for which a compulsory standards specification has been declared.
- **Manufacturer:** any person (or business) uses two or more ingredients/ raw materials in Jamaica to produce any commodity for which a compulsory standards specification has been declared.
- **Processor:** any person (or business) uses one ingredients/ raw materials in Jamaica to produce any commodity for which a compulsory standards specification has been declared.
- **Administrative Closure:** a non-judicial action taken solely by the NCRA or its designate to indicate that an Importer or Manufacturer or Processor has permanently discontinued trading and failed to complete the Notice of Discontinuance.

Reminders:

- Commodity means *“any article, product or thing which is the subject of trade or commerce.”*
- Regulation 8B (1) of the Standards Regulations, 1983: *“...every person who imports into Jamaica (other than for personal use), manufactures or processes any commodity for which a compulsory standard specification has been declared shall be registered under this regulation in respect of that commodity.”*
- Regulations 8B (5) and 8B (6) of the Standards Regulations, 1983: *“A registration under this regulation shall be valid for one year... [and]...Upon the expiry of a registration, an application for renewal of registration may be made ...for another year...”*
- Regulation 12(a) of the Standards Regulations, 1983: *“Any person who – (a) contravenes any of the provisions of regulations 7, 8A and 8B...shall be guilty of an offence and shall be liable on summary conviction before a Resident Magistrate to a fine not exceeding three million dollars and in default of payment to imprisonment for a term not exceeding twelve months.”*
